DEAR SCHUYLER:

THANK YOU FOR YOUR LETTER OF THE 16TH. IT IS GOOD TO LEARN THAT THE SILVER AND PHOTOGRAPHS ARE STILL INTACT. CONTRARY TO YOUR LETTER; SENDING THESE OVER FOR MY INSPECTION WOULD SERVE A VERY GOOD AND USEFUL PURPOSE; NAMELY, REINSTALL IN ME CONFIDENCE IN YOU.
