MIT team finds evidence of hydrogen combined with oxygen in interstellar space

Hydrogen combined with oxygen—as hydroxyl (OH) radicals—may have been detected and measured in interstellar space for the first time.

The discovery, according to <u>Dr. Charles Townes</u>, provost of Massachusetts Institute of Technology, is one of the most important events for radio astronomy in this decade. From a theoretical standpoint, it gives scientists "an additional key to figuring out what is going on in galactic space." From a practical standpoint, it will enable radio astronomers to figure out velocities,

temperatures, and distribution of oxygen in space. The first experimental evidence of the presence of hydroxyl radicals in space was offered this week by a team of scientists from the MIT Research Laboratory for Electronics and MIT's Lincoln Laboratory. Using radio astronomy and digital computer techniques, the group ended several years of search by radio astronomers for some evidence of elements—in combination—

in interstellar space.

The team reports that the radio frequencies at which the hydroxyl radicals were detected were in close agreement with predictions based on theoretical calculations and laboratory experiments. Their measurements showed the radicals to be present in interstellar space in a ratio of one to every 10-million hydrogen atoms.

Finding the hydroxyl radicals is expected to help astronomers chart the distribution and abundance of OH—and hence, hydrogen and oxygen—throughout the galaxy.
